## GRIFFIN PARC RESIDENTIAL ASSOCIATION, INC. PAVILION RULES

Revised July 14, 2014

The use of the pavilion is intended exclusively for the residents of Griffin Parc and their guests.

- Hours: 6:00 am to 11:00 pm
- Griffin Parc residents (per home address) may have up to 15 guests and must be present with guests at all times.
- Entry to the pavilion shall be through the gates only. Climbing over the fence or gate is prohibited. The gates must be locked at all times.
- Children under 14 must be supervised by an adult at all times.
- Keep music at a level that does not disturb others using the pavilion. No speakers/amplifiers larger than 2 ft. by 3 ft. are allowed.
- No pets of any nature are allowed inside the pavilion area.
- No glass or breakable items are allowed inside the pavilion area.
- Bicycles, skateboards, scooters and motorized or battery operated vehicles are not permitted inside the pavilion area.
- Residents using the grill must clean up after themselves. Do not leave any flammable supplies. Use of the grill is limited to two (2) hours.
- Report any vandalism or pavilion concerns to SBB Management Company at 972.960.2800.
