Architectural Modifications

Speed Limit

The Association cares for all of our residents and guests. For the safety of everyone in the community, Griffin Parc requests that all residents and visitors do not exceed **20 MPH** when driving in the community.

Talking Trash

All trash and recycling must fit inside your cart with the lid closed. If you are unable to fit all trash items inside your cart, you will need a special bulk pickup. Overloaded carts will not be collected.

Bulk trash service is offered by the City of items too large to fit in your trash container, up to 5 items a month. Interactive maps are avialabe at www.friscotexas.gov to find out when your bulk items will be collected. Call 972-292-5900 before noon the day before your area's scheduled pick up to make arrangements.

Yard of the Month

Yard of the Month will run from May through September in 2019. In October, homes will be judged on their Halloween decorations and there will be a Holiday Decorating contest in December.

The program is managed by the Landscape Committee. Judges will be looking at the overall quality of and appearance of the house and lot in general. Winners will receive a \$50.00 gift card and get to display the Yard of the Month sign in the front yard for the month of distinction. The sign will be returned to the Landscape Committee for use by the next month's winner.

Griffin Parc is dedicated to improving the quality of living and appearance in the community. The Association encourages residents to take pride in their home and neighborhood. In turn, the HOA wants to reward those who do a superior job in maintain their yards in such a way that they enhance the overall curb appeal of the entire community.

Compliance

The Association's number one priority is maintaining and enhancing property values for all of its members. Homes and yards with dilapidated or deteriorated appearances can adversely affect the community's appearance, which will cause a decline in home values. The following is a collection of common compliance issues in the community.

Landscaping

- Mowing, edging, and weed treating
- Fertilizing
- Tree trimming/lifting-trees cannot block the streets or sidewalks
- Replacing dead or missing grass, shrubs and trees
- Weeding shrub beds and tree beds
- Repairing cracked or broken shrub/tree bed borders

Exterior Painting

- Chimneys, siding, trim, shutters, and front doors must be painted/stained and maintained properly
- Changing your paint color requires approval from the Architectural Review Committee

Fences

- Fences that were previously stained must be maintained (stain must be uniform in color)
- Must be standing upright (not leaning)
- Missing or broken pickets, lattice and runners must be replaced
- Wrought iron fences and railings need to be maintained (i.e. no rust or faded/peeling paint)



Debris

- The driveway cannot be used for storage or discarded items
- All landscaping debris must be collected and stored properly until bulk trash pickup
